

'Take the Treaty Pledge and win' – December 2025

Conditions of Entry

On Thursday 18 December 2025 we launched a 'Take the Treaty Pledge and win' giveaway that will run until Sunday 18 January 2026.

A "lottery" will be drawn in which 5 people will be selected at random and each offered a Treaty Merch Goodie Pack valued at \$225. Entry into this lottery is by filling in and submitting our 'Treaty Pledge' online form during the competition period. This trade promotion lottery is run by the First Peoples' Assembly of Victoria Ltd (ABN 51 636 189 412) (Assembly, we, us or our) of 48 Cambridge Street, Collingwood, Victoria 3066.

1. General conditions
 - 1.1. Entry is free and open to all.
 - 1.2. Entry into this lottery is deemed acceptance of conditions of entry.
 - 1.3. One entry is permitted per person.
 - 1.4. Employees of the Assembly are ineligible to participate.

 - 1.6. Entry to the lottery will open at 10 am on 18 December 2025 and will close on 11:59 pm 18 January 2026.
2. Lottery draw
 - 2.1. The draw for the winners will take place at 3 pm on 20 January 2026. Entrants need not be present to win.



- 2.2. The prizes are Treaty Merch Goodie Packs valued at \$225 each. There are five (5) prizes total, one (1) winner per prize. Total prize pool valued at \$1,125. Prizes will not be drawn in any particular order.
 - 2.3. Each entrant will be assigned a number, which will be drawn at random through government certified electronic draw system www.randomdraws.com.au provided by the business Trade Promotion and Lotteries Pty Ltd (ACN 601 297 330) (TPAL Electronic Draw System).
3. Winning entry
 - 3.1. The winners will need to show proof of identification before the prize is released.
 - 3.2. The winners will be notified in writing by email (and additionally by phone where possible) by 23 January 2026 and each of the winners' names or initials will be published on the Assembly's website for 28 days.
 - 3.3. The prize cannot be transferred or redeemed for cash unless deemed faulty.
4. Collection of prize
 - 4.1. The prize will be delivered to the winners within 28 days after the winners are declared. The Assembly will make all reasonable efforts to locate the winners and deliver the prize.
 - 4.2. If the Assembly is unable to locate a winner and deliver the prize after reasonable efforts have been made to identify the winner, the winner may be substituted via a second draw.
